#### 1. Call to Order and Introductions

Chairperson Noreen O'Toole called the meeting to order at 12:00 P.M. and then read the Meeting Accessibility Statement and the Title VI Notice of Protection Statement. Those present then introduced themselves.

#### 2. Public Comments

There were no public comments.

## 3. Minutes of the September 7, 2017 Meeting

Chairperson Noreen O'Toole asked if the members had reviewed the minutes of the September 7, 2017 Meeting. The members then voted to endorse the minutes of the September 7, 2017 Old Colony JTC Meeting. Dan Salvucci abstained from the vote.

#### 4. Communications

Shawn Bailey reviewed the contents of the communications staff report. Included were letters of

correspondence, as well as notices of workshops and conferences.

Chairperson O'Toole asked if more CPTC courses can be held in Brockton. Bruce Hughes stated that if there is enough interest we can schedule them around Brockton.

#### 5. Reports

## A. Brockton Area Regional Transit Authority (BAT)

Charles Kilmer stated that BAT is attending their annual Strategic Planning Meeting today and therefore are unable to attend the JTC Meeting.

## B. Greater Attleboro-Taunton Regional Transit Authority (GATRA)

Paul Chenard stated that GATRA is having some coverage issues with service in the southern portion of Plymouth. GATRA is working to find resources in order to meet demand.

## C. South Coast Rail Project

Paul Chenard provided an update on the South Coast Rail Project. In May 2017, Secretary Matthew Beaton of the Executive Office of Energy and Environmental Affairs (EOEEA) issued a Certificate on the Notice of Project Change. The Certificate on the NPC requires the preparation of a Draft Supplemental Environmental Impact Report (DSEIR). A DSEIR will be available for public review in early 2018 concerning the alternative phase 1 approach.

#### 6. Old Business

#### A. FFY 2017-2021 Transportation Improvement Program (TIP) Implementation

Charles Kilmer provided an update on projects with changes. They are as follows:

#### 7. New Business

- A. Massachusetts Project Intake Tool (MaPIT) Overview and Presentation
  - Quinn Molloy, MassDOT Office of Transportation Planning

Quinn Molloy provided an overview and presentation on the Massachusetts Project Intake Tool (MaPIT). The new Project Intake Tool is a web-based application that streamlines the process of completing Project Need Forms (PNFs) and the Project Initiation Forma (PIFs).

The MaPIT tool populated information compiled by MassDOT through GIS and screens for information relative to condition of assets, mobility and bikes, safety, and economic, social equality and environmental issues. MaPIT will expedite project initiation, environmental permitting, scoring and project delivery, according to MassDOT. Features and benefits of MaPIT include:

- Automatic Project Need Form screening against all relevant GIS layers:
  - Existing facility information
  - Condition of assets
  - Mobility & Bike/Ped
  - Safety
  - o Economic
  - Social Equity
  - Environmental
- Maps project location for MassDOT and public viewing
- Automatic transfer of information from PNF to PIF
- Saves additional PIF time, allowing proponent to reference geoprocessing
- Paperless and easy to track where the proponent is in the approval process
- Once approved, project is assigned a number and information is automatically transferred to the MassDOT Project Info Software System
- Expedites Project initiation, environmental permitting, scoring, and project delivery

Dan Salvucci asked if instructions will be sent to each town on how to use this software. Quinn Molloy stated that information will be sent to each town.

Sid Kashi asked if towns can still do it the old way. Pam Haznar stated that this will soon be the only way you can initiate a project.

#### B. Brockton – Centre Street (Route 123) at Plymouth Street Road Safety Audit (RSA)

Ray Guarino provided an overview of the Centre Street (Route 123) at Plymouth Street RSA. This intersection is a high crash location and is listed on MassDOT's Top 200 Hazardous Intersection list. The Brockton DPW has submitted a Project Need Form (PNF), to begin the TIP process. It is expected that

CDM Smith will be the design engineering consultant for the project.

Potential safety enhancements at this intersection include:

- Trim back vegetation
- Add lighting
- Update flashing beacons to LED
- Place stop signs on both sides of the road
- Increase enforcement
- Permit parking for residents
- Outreach education on pedestrian safety partnering BAT and Brockton Schools
- Road diet for Centre Street between Commercial Street and Plymouth Street
- Add bicycle lanes depending on right of way availability
- Add tactile warning tiles to ramps at the intersection
- Limit movements (right turn in and out) and/or eliminate curb cuts close to the intersection
- Eliminate exclusive right turn lane on the Centre Street eastbound approach
- Upgrade guardrail
- Signalize the intersection or construct a roundabout

Nick Giaquinto stated that the City of Brockton is in full support of this project.

Ray Guarino thanked BAT for hosting the Road Safety Audit.

#### C. FFY 2018-2022 Transportation Improvement Program (TIP) Implementation

Charles Kilmer discussed the FFY 2018-2022 TIP Implementation. Charles Kilmer stated that MPOs are being asked to amend their TIPs. There are some fiscal constraint issues of funding categories.

Pam Haznar stated that municipalities need to keep their eye on the ball as far as developing projects and make sure projects stay on track. Pam Haznar asked when the 2019-2023 TIP process will start. Charles Kilmer stated that the process will start in November. This will allow us to develop the draft document and go through the MPO process.

# B. Staff Reviews on ENFs, EIRs, and NPCs

Charles Kilmer summarized the Environmental Notification Forms (ENFs), Environmental Impact Reports (EIRs), Notices of Project Changes (NPCs), and Certificates for projects within the OCPC region that are undergoing Massachusetts Environmental Policy Act (MEPA) Office review.

#### **ENF**

## EEA #15764 - Atlantic Link Project (ENF)

The Project involves the installation of a subsea high-voltage direct-current ("HVdc") transmission line to deliver clean energy from Atlantic Canada to Massachusetts, approximately 19 miles of which will traverse Massachusetts state waters. At landfall in Plymouth, the Project would include the construction of an underground HVdc cable extending approximately 2,375 feet, HVdc converter station, substation, and transmission line tap within currently undeveloped land owned by Entergy.

### C. Regional Concerns and Local Community Transportation Issues

Charles Kilmer relayed thanks to MassDOT and the Town of Plymouth for their meeting in regard to Plympton Road (Route 80) pedestrian accommodations in Plymouth near the West Elementary School.

Bob Wood stated that there have been several complaints going southbound on North Main Street (Route 28) into West Bridgewater. There is confusion as to what lane to be in to get to Route 28 SB. Pavement markings in the lanes would help.

Pam Haznar stated that there is a Cape Cod Canal Area Transportation Study ongoing right now by MassDOT. Looking at existing bridges and whether to maintain or replace them. There should be a public informational meeting coming up soon.
