- The limited English proficiency office at the BAT Centre is currently under renovation.
- BAT will be utilizing the WeDriveU Services to provide transportation to people going to the Amazon site in Stoughton. There will be 5 trips in the morning, afternoon, and evening. WeDriveU will be providing BAT with ridership reports for those trips.

### 7. Draft FFY 2018-2022 Old Colony Transportation Improvement Program (TIP) Amendment 1

Review and Potential Release to Public Comment Period

Charles Kilmer reviewed the Draft FFY 2018-2022 Old Colony TIP Amendment 1. The FFY 2018-2022 TIP Amendment 1 adds the Brockton Main Street Circulation Study (Federal Earmark MA-214) Funding for Design Project, and adds six (6) projects that were awarded as part of the 2017 Community Transit Grant Program.

#### 1. CITY OF BROCKTON

- AMENDMENT: ADD PROJECT MA-214, BROCKTON MAIN STREET CIRCULATION STUDY (FEDERAL EARMARK) FOR DESIGN
- COST IS \$476,691.99 (\$381,353.59 FEDERAL; \$95,338.40 CITY OF BROCKTON)

### 2. BROCKTON AREA TRANSIT (BAT)

- AMENDMENT: ADD PROJECT BUY REPLACEMENT <30 FT BUS (7)</li>
  - COST IS \$462,800 (\$370,240 FEDERAL; \$92,560 STATE)

### 3. BROCKTON AREA TRANSIT (BAT)

- AMENDMENT: ADD PROJECT OPERATING ASSISTANCE TO CONTINUE TO PROVIDE AVON-STOUGHTON SERVICE
- COST IS \$52,000 (\$26,000 FEDERAL; \$26,000 LOCAL)

#### 4. BROCKTON AREA TRANSIT (BAT)

- AMENDMENT: ADD PROJECT OPERATING ASSISTANCE TO CONTINUE TO PROVIDE SERVICE TO THE TOWN OF ROCKLAND
- COST IS \$100,000 (\$50,000 FEDERAL; \$50,000 LOCAL)

### 5. OLD COLONY PLANNING COUNCIL (OCPC)

- AMENDMENT: ADD PROJECT OPERATING ASSISTANCE FOR VOLUNTEER TRANSPORTATION PROGRAM (VTP)
- COST IS \$64,000 (\$32,000 FEDERAL; \$32,000 LOCAL)

### 6. SOUTH SHORE COMMUNITY ACTION COUNCIL (SSCAC)

- AMENDMENT: ADD PROJECT OPERATING ASSISTANCE TO SUPPORT SSCAC TRANSPORTATION PROGRAM
- COST IS \$80,000 (\$40,000 FEDERAL; \$40,000 LOCAL)

### 7. SOUTH SHORE COMMUNITY ACTION COUNCIL (SSCAC)

- AMENDMENT: ADD PROJECT BUY REPLACEMENT VAN (7)
- COST IS \$449,400 (\$359,520 FEDERAL; \$89,880 LOCAL)

Mayor Bill Carpenter stated that money has finally been approved for the design of a project to make two way traffic on Main Street in Brockton. The City of Brockton requests that this project be added to the TIP Amendment so we can utilize these dollars.

Dan Salvucci asked if the one-way pattern on Main Street is hurting businesses. Mayor Bill Carpenter responded that a two-way traffic pattern would be more advantageous to the businesses.

Chairperson Woelfel asked if there is a motion to endorse the Draft FFY 2018-2022 Old Colony TIP Amendment 1 and to release it for a 21-day public review and comment period. A motion was made and was seconded.

The Old Colony MPO voted unanimously to endorse the Draft FFY 2018-2022 Old Colony TIP Amendment 1 and to release for a 21-day public review and comment period.

#### 8. Massachusetts Project Intake Tool (MaPIT) Overview and Presentation

Quinn Molloy, MassDOT-Office of Transportation Planning

Quinn Molloy provided an overview and presentation on the Massachusetts Project Intake Tool (MaPIT). The new Project Intake Tool is a web-based application that streamlines the process of completing Project Need Forms (PNFs) and the Project Initiation Forma (PIFs).

The MaPIT tool populated information compiled by MassDOT through GIS and screens for information relative to condition of assets, mobility and bikes, safety, and economic, social equality and environmental issues. MaPIT will expedite project initiation, environmental permitting, scoring and project delivery, according to MassDOT. Features and benefits of MaPIT include:

- Automatic Project Need Form screening against all relevant GIS layers:
  - Existing facility information
  - o Condition of assets
  - Mobility & Bike/Ped

- Safety
- o Economic
- Social Equity
- o Environmental
- Maps project location for MassDOT and public viewing
- Automatic transfer of information from PNF to PIF
- Saves additional PIF time, allowing proponent to reference geoprocessing
- Paperless and easy to track where the proponent is in the approval process
- Once approved, project is assigned a number and information is automatically transferred to the MassDOT Project Info Software System
- Expedites Project initiation, environmental permitting, scoring, and project delivery

Pat Ciaramella commended MassDOT for putting this tool together. This is a great opportunity for MassDOT and communities to minimize errors in the project initiation process.

Charles Kilmer stated that this concept is consistent with USDOTs Everybody Counts Initiative.

### 9. Administrative Matters, Other Business, and Date and Time of Next Meeting(s)

Charles Kilmer highlighted two items in the staff report. MassDOT Highway ADA Transition Plan Public Meeting will be held at Independence Associates in East Bridgewater on October 26, at 4:30 p.m. There will be a Transportation Sector Emissions Listening Session on November 9, at 6:00 p.m. at the West Middle School in Brockton.

The next Old Colony MPO meeting will be held on November 21, 2017.

### 10. Adjournment
